MINUTES Annual Congregation Meeting

January 27, 2019

The Meeting was held in the sanctuary and was called to order at 12:15 p.m. by President Marian Filtz. The President declared that a Quorum was present.

Distributed to the members was the Annual Report Booklet, full report of the Treasurer, and Proposed Amendments to the Bylaws of Reformation School.

President Filtz announced that the Agenda for the meeting was printed on page 2 of the Annual Report. There being no objections, the Agenda was accepted.

The Pastors led a devotional activity.

President Filtz requested approval of the minutes of the Annual Congregational Meeting held on January 28, 2018, which were printed on page 3 of the booklet. A Motion was made and seconded that the minutes be accepted as printed. The motion passed.

President Filtz called upon Pastor Wayne, Pastor Alina and Deacon Beth for their Ministry Review. The rostered staff highlighted their written reports with brief comments on several projects in 2018: Art in the Heart of Worship, Interfaith connections like Art Tolerance, the participation of our youth at the ELCA youth gathering and our new Welcome Statement.

President Filtz recognized and thanked the staff and the congregation for its support of the entire staff.

NEW BUSINESS

The proposed amendments to the bylaws of Reformation School were presented for consideration. Background information was presented that the Bylaws under which Reformation School has operated since its incorporation in 1999 have been in need of a number of editorial amendments. The proposed amendments had been reviewed by the School Board. Under the bylaws the Congregation has the sole power to revise the bylaws which were sent to all members electronically and printed copies were also available for review. The proposed bylaw amendments came to the Annual Meeting as a recommendation of Congregation Council and, accordingly, did not need a Motion or a second. A vote was requested on the proposed bylaws amendments and the amendments were adopted.

The 2018 Report of the Treasurer was presented for action. Tom Conroy, treasurer, made comments concerning the report and indicated that there was an adjustment of \$886.00 to be made between accounts. The Treasurer indicated that an Amended Report would be submitted to reflect the correction. The Report of the Treasurer was accepted with the understanding that it would be amended. Attached to these minutes is the submitted Amended Report. Members Mike Polito, Ron Brzowski and Dave Helms shared comments about activities and participation in the life of our Church which cause them to celebrate the various ministries.

The following people were nominated for Congregation Council for three-year terms beginning June 1, 2019, and ending May 31, 2022: Walt Woerheide, Uli Neubert, Debbie Conley and Beverly Norton.

The following people were nominated for a one-year term as Youth Representative on Congregation Council beginning June 1, 2019, and ending May 31, 2020: Layla Phillips and Megan Gress.

There being no further nominations, a Motion was made and seconded to close the nominations. The Motion was adopted and the nominations were closed. A Motion was made and seconded to elect the slate of nominees. The Motion passed and the slate of nominees declared elected.

The following people were nominated for election to the Nominating Committee for 2019: Andrew Marcus, Emily Black, Steve Niss, Beth Benzing, Mike Defronzo and Sarah Bocian. There were no addition nominations and a Motion was made and seconded to close the nominations. The Motion passed and the nominations were closed. A Motion was made and seconded to elect the slate of nominees. The Motion passed and the slate of nominees was declared elected.

The proposed budget for 2019 was printed on pages 18 and 19 of the Annual Report. The proposed budget was a recommendation of Congregation Council and, as such, did not require a Motion and second. President Filtz indicated that the Report of the Treasurer contained comments about the proposed budget and the Treasurer presented a forum on Sunday, January 20, 2019, where the budget was reviewed and questions answered. The proposed Budget was approved. (It should be noted that an additional opportunity for Congregation members to ask questions during the Annual Meeting was not made available and this was an oversight.)

OLD BUSINESS

A brief update on Sanctuary improvements was provided. The improvements may involve new lighting, painting and audio system as funds become available.

ADJOURNMENT

President Filtz thanked the members for attending and the Hospitality Ministry for the refreshments prior to the meeting. A Motion was made and seconded and the Motion to Adjourn passed. Deacon Beth Ann Barkhau provided closing thoughts and prayer. The Annual Meeting adjourned at 1:17 p.m.

Special Congregational Meeting December 29, 2019

President Richard Hughey called the meeting to order at 11:10 am. He declared that a quorum of voting members was present.

President Hughey presented the following resolution which was adopted by Congregation Council on November 12, 2019:

Be it RESOLVED, that Reformation Lutheran Church, Media, PA, extend a call to Deacon Beth Ann Barkhau to serve as Director of Faith Engagement on a part-time basis (25 hours per week).

President Hughey introduced Dr. Addie J. Butler, a member of the Evangelical Lutheran Church of the Reformation, Philadelphia, who was appointed as the official Deputy by the Bishop of the Southeastern Pennsylvania Synod, ELCA, to conduct the election. She began with prayer, and then asked if there were any questions before the voting. There were none.

Tellers, led by David Helms, passed out slips of paper on which voting members were instructed to write Yes, No, or Abstain to vote on the resolution to call Deacon Beth Barkhau.

After the votes were counted, Dr. Butler announced that the results of the election are as follows: Ballots cast: 86; es: 83; No: 2; Abstain: 1.

Dr. Butler declared that Deacon Beth Barkhau was elected.

Deacon Beth was called back into the sanctuary and the results were shared with her. Deacon Beth expressed what an honor it has been to serve at Reformation. She looks forward to continuing her call with both pastors and all of our brothers and sisters in Christ. Gratitude was expressed to Dr. Butler, as she was a role model for her 30 years ago. Deacon Beth noted that her husband, Bob Barkhau, has been a wonderful support and loving partner. Deacon ended her remarks with prayer.

The meeting was declared adjourned at 11:35 am.

COMMUNITY ACTION MINISTRY

Linda Bucher, Chair

This year was a busy one for the Community Action Ministry Team. This year the Team continued the following ministries that had been previously established:

- Provided dinner for the homeless at the Life Center in Upper Darby five times during the year.
- Provided beverages for the Welcome Church on 3 Sundays during the year.
- Distributed grocery bags during Easter, Thanksgiving, and Christmas holidays, which were filled by members of the congregation, and delivered the Migrant Ministries, 2nd Time Around Grandparents.
- Organized and delivered gifts for the St. Nicholas Project (gift giving opportunities to benefit 7 agencies that serve those in need).
- Collected and delivered over 400 pounds of food for the Media Food Bank and Chester Eastside Ministries during the fall food drive held at Trader Joe's in Media.
- Collected and delivered cans of soup during the January "Souper Bowl of Caring".
- Organized 2 blood drives.
- Collected School supplies for children in need.
- Collected underwear for the Needlework Guild's annual collection.

The team has worked to establish the following new partnerships and opportunities for outreach:

- Reformation has become a drop off site for Cradles to Crayons, an agency that serves children.
- Sponsored and participated in the "Feeding Thousands" event.
- Sponsored QPR (Question, Persuade, Refer), a suicide prevention workshop.
- Provided meals for The Well, a shelter for homeless women in Philadelphia.
- Assembled and delivered gift food baskets to local fire and police departments (Media and Upper Providence).

During the next year, we are working to expand our support of and involvement in the Well, possibly providing meals each quarter, and exploring other needs that we might fill for this shelter.

The congregation has shown generous and overwhelming support of all of these outreach ministries, and we are abundantly blessed!

ECOLOGY MINISTRY

This year the Eco Ministry Committee experienced great sadness at the passing of Debbie Felton, the dedicated, capable, and inspiring leader of the committee for many years. Her devotion to the work of being a steward of the environment left an imprint on every aspect of our committee's work and mission.

Throughout the year the Eco Ministry Committee focuses on caring for creation and responsible citizenship from the congregational level to the global level. To this end, Eco Ministry sponsored road clean-up events in March and October. Turnout was good on both occasions and Rose Tree Road got a good freshening up!

Several opportunities to get out and enjoy the natural world that surrounds us were also included on the Eco Ministry calendar – a trip to the Heinz Refuge in April, a Fall Hike and Bible Study in September, and an Eagle Watch at the Conowingo Dam in October.

The Eco Ministry Committee lineup also included two movie nights. The first was in May and the featured movie was <u>Who</u> <u>Owns Water?</u> which followed the course of a river system in the south and raised issues about water rights; a river trivia contest was part of the movie night, as well. In November the Eco Ministry Committee participated in an interfaith movie night at Congregation Beth Israel to view and discuss the film <u>From Paris to Pittsburgh</u>.

Eco Sunday was April 28, 2019. The theme was "When It Rains It Drains," and the agenda included information and activities focusing on stormwater.

Rounding out the work of the Eco Ministry Committee is the ongoing maintenance of the pollinator garden and birdbath, monitoring of our fair trade and energy star certifications, and regular postings of eco tips in the Reformation Times.

LIBRARY COMMITTEE

Sue Bianco and Laura Reiter, Co-Chairs Reformation's self-serve library includes books, periodicals, videos, and audio cd's in collections for children, teens, and adults.

<u>Outreach and Programs</u>: In our 19th year of operation, we continue to reach out to ministries and groups with resources:

- Jennifer Troutman, Sunday School Superintendent, periodically takes library items to classes for the children to sign out.
- The Eco Ministry's Earth Day program is supported with a display and book list.
- Books read with lively and thought-provoking discussions by the guarterly Library Book Club meetings were:
 - Sorn a Crime, by Trevor Noah
 - Curious Incident of the Dog in the Night, by Mark Haddon
 - The Day the World Came to Town: 9/11 in Gander, by Jim DeFede
 - ✤ A Piece of the World, by Christina Baker Kline
- A Thrivent grant was obtained for the purchase of books in the amount of \$250 to support the curriculum of Hunger and Homelessness initiated by the Director of Faith Engagement
- Books purchased to support the bulletin board topic of contemporary voices prompted book sign-outs.
- In support of Reformation's statement of inclusion, the Library purchased a large print NRSV Bible, accepted the donation of a DVD, the American Sign Language Version of My Bible Stories and purchased *The Inclusive Bible: The First Egalitarian Translation*, by Priests for Equality.

- Consulted with Pat Fontes (mother of Reformation member Dave Fontes) in the start-up of her church library.
- Began planning for a regional network of church and synagogue libraries with a Meet-Up planned for May 2020.

Library Operations: What we do

- Purchase, catalog (using ResourceMate 4.1.1 Essential Plus), and label new acquisitions
- Review donated items
- Maintain organization of the collection
- Process loans, returns and overdue items
- Plan and execute quarterly displays
- Submit items to Reformation Times, church website, and Facebook
- Conduct a yearly inventory, with special thanks to Rachel Bingeman and Sarah Bingeman for their assistance; six books were missing without having been signed out

<u>Webpage</u>: The Library has its own webpage (relclibrary.org) and holdings are searchable from any computer.

<u>Library Collection</u>: We maintain an optimal size of approximately 1,600 items based on shelf capacity. Donated items are welcome in our collection's growth and diversity.



ENDOWMENT MINISTRY

John Pritchard, Chair

This report is for the fiscal year 2019. During the year, September 30, 2018, to October 1, 2019, a total disbursement of \$37,137 was made from the various sub-accounts of the Endowment Fund. The following are the disbursements: \$2,500 Summer Intern, \$3537 Vibrant Faith Summit, \$1500 Leadership for Faithful Innovation, \$1,500 Interfaith Center, \$2,800 Chester Children Chorus, \$5,000 Pangani Scholarship, \$1,800 Chester Community Coalition, \$1,000 ARTolerance, \$1,000 SEPA Stewardship Generosity, \$1,500 Media Fellowship 75th anniversary, \$15000 Sanctuary Sound System.

Since 2000, the Endowment Fund has disbursed a grand total of \$412,294. We should be excited about the active role the Endowment Fund has played in support of our mission.

The total market value of the Endowment Fund as of September 30, 2019, is \$653,282, an increase vs. 2018 of \$46,459. The following balances as of September 30, 2019, are established for the Endowment Fund Accounts:

Program Account	\$37,411
Capital Improvement Account	\$16,028
Outreach Ministry Account	\$66,454
Investment Account	\$533,389

This allocation makes available a total of \$119,893 in support of the ministry of Reformation.

Trustees of the Endowment Fund for 2019 were: John Pritchard, *Chairperson* (term expires 1/21), Andrew Marcus, *Vice-Chairperson* (term expires 1/20), Pat Burke, *Treasurer* (term expires 1/22), Gary Kamin, *Secretary* (second term expires 1/24), and Christina Selby, *Trustee* (term expires 1/23). Amy Dorfmeister served until mid-year, resigning for business reasons, and was replaced by Christina Selby.

Notably, this same committee also administers the Reinhard (\$41,115), Moser (\$116,380), and Leibig (\$36,437) funds.

PROPERTY MINISTRY

Emily Black, Council Liaison

The following is a synopsis of the property committee's actions throughout 2019. Thank you to all volunteers who help with the upkeep of our beautiful facility!

- Procured ice melt for walkways and placed at doors for general use.
- Monitored walkways and parking areas all though the winter for icing and refreezing. Salted parking lots as needed after initial plowing services.
- Dave Black and John Hess on call throughout the year for maintenance issues, alarm calls, etc.
- Provided email address and cell phone number to Nursery School and Stay and Play for any issues or concerns in or around the building.
- Reviewed and responded to Reformation Schools Summer Maintenance list.
- Responded to numerous and varied maintenance calls from Reformation Schools.
- Coordinated and participated in spring, summer, and fall cleanups on church grounds.
- Procured and facilitated sub-contractors to do various repair jobs including plumbing, electrical, and groundskeeping work.

HIGHLIGHTS FROM THE TREASURER'S REPORT

Tom Conroy, Treasurer

The full Financial Report of the Treasurer including Budget analysis is published and available as a separate document.

2019 Summary

Regular member contributions were consistent throughout the year with several strong months of over budget performance. Total Envelope Giving performance for 2019 of \$554K was \$14.8K or 3% over budget and exceeded 2018 performance by \$40.3K. Total Revenue before yearend balancing adjustments was \$708K, which was 2% or \$15K over budget. Expenses for the year of \$663K were significantly under budget by 4% or \$\$30K before year-end balancing adjustments, largely due to savings in Other Personnel, partially offset by significant unbudgeted expenses in facility maintenance. As a result, a \$45K Operating Surplus was generated. Adjustments to balance operations with the Surplus included increasing SEPA Synod benevolence by formula because of higher than budgeted Income totaling \$1.6K, repaying the Always in *Mission* Fund \$34.5K of the \$53.9K transferred to support the Staff positions of Deacon and Custodian, fund the Surplus/Deficit Reserve Account \$3.7K to bring it to an even \$10K and lastly, fund a discretionary pool of \$5,000 for potential 2019 Staff Bonuses for Council consideration.

2020 Planning

The following chart details results from the very successful 2020 You Belong Stewardship campaign rooted in transferring funding for the congregation's Director of Faith Formation Staff position, held on an expiring term call by Deacon Beth Barkhau, from the previous, Always in Mission Capital Campaign to a budgeted position covered by ongoing current operating fund Income. Member were asked and responded to an appeal to increase their Envelope Giving to cover the expenses for the Director of Faith Formation Staff position and enable a new, open ended, permanent call. Campaign results were highly successful and support an Envelope Giving projection of \$584,000, which is significantly above 2019 commitments and 2019 Actual contributions. This response is the represents the largest ever in the congregation's history surpassing the previous high achieved only last year in the Walk by Faith campaign. This response is indicative of both the congregation's support of, and ongoing commitment to, the enhanced Ministry provided by Deacon Barkhau. Even more so, the response is a testimony of the spiritual growth that Deacon Beth has provided our community in Christ.

Summary Comments

Financially, 2019 bettered an exceptional 2018 with member contributions to operations exceeding budget by 3%, with a Stewardship campaign that resulted in commitments exceeding those of 2019 by 14% or \$61K. Envelope Giving performance significantly over budget has occurred in five successive years. With such obvious ongoing congregational support of operations and programs, leadership is positively influenced in their work. Timely contributions consistent with pledged commitments have a very positive effect on cash flow and are greatly appreciated.

Above budget Income performance and good expense management and control exhibited by Staff in 2019 produced an operating Surplus that enabled the current fund to absorb 64% of the enhanced Ministry provided by the Deacon, increase Benevolence, fund a discretionary Staff Bonus Pool and build the positive Surplus / Deficit Reserve to \$10K. Numerous unplanned building and grounds maintenance projects were funded as well computer upgrades for office Staff. From an operations management perspective, 2019 was a year of dealing with these unplanned building infrastructure issues, while increasing ministry opportunities for our members through increased participation in community, synod and inter-faith activities.

The Holiday Offering Fund saw steady Income over 2019 and many requests were funded. It was a significant year of matching congregational donations to disaster relief ranging from wildfires, floods, tornadoes and hurricanes. With a > \$10K Christmas collection, the Fund has a healthy \$12K balance going into 2020. Please always plan ongoing Holiday Offering Fund donations to supplement your personal giving plan for Lent, Easter, Pentecost, Reformation, Thanksgiving and Christmas in 2020.

Bookkeeping in 2019 was exceptional through the work Christine Corson our Administrative Assistant for Finance. Normalizing financial processes under the new Realm chart of accounts for both congregational and Reformation Schools operations has been a major accomplishment in 2019. Christine is an engaged and highly competent administrator and invaluable to Reformation's daily operations and financial controls.
