In signing this contract, we accept and agree to the following:

- 1. There is a \$60.00 non-refundable registration fee paid yearly per child.
- 2. The full month's tuition payment and calendar are due by the **FIRST** of each month.
- 3. A fine of \$15.00 is levied for fees not paid by the FIRST of the month. If the first falls on a Saturday or Sunday or a holiday, then payment is expected by the following Monday.

The fee schedule for the 2024/2025 school year:

- 1. \$11.00 per hour Hours are figured on a daily basis. No longer combining hours for AM & PM; they are separate sessions.
- 2. \$264.00 minimum fee per month per child.
- 3. During the month of June, the tuition is prorated to meeting ½ the monthly minimum.
- 4. \$5.00 late pick-up fee for each 5 minutes after 6:00 pm closing per child starting at 6:01 pm
- 5. There will be a \$30 discount on the 2nd lowest tuition in a family.
- 6. On extended days tuition rate is as follows: \$50.00 (for up to 6 hours of care) and \$80.00 (for up to 11.5 hours of care). NO hourly rate on full days.
- 7. I will notify Stay and Play on the days my child will not be attending due to illness or other reasons. I will notify the center if I would like my child to attend and they are not scheduled to attend. If I fail to notify the center, I will be fined a \$10.00 fee.

I will notify the staff of Stay and Play if my child is to be picked up by someone other than the designated person.

General Permission:

My child has permission to walk to Rose Tree Park in June during the last week of school. There will be proper supervision and local police to escort the children across Rose Tree Road.

Dear Stay and Play Families,

The 2024/2025 registration process for Stay and Play begins this month.

THE BOARD HAS ADOPTED THE FOLLOWING FEE SCHEDULE:

- \$60.00 yearly registration fee per child (non-refundable).
- \$11.00 per hour for each hour or partial hour of care.
- \$264.00 per month minimum per child (*this amount is prorated in June).
- \$5.00 late pick-up fee for each 5 minutes after 6:00 PM closing per child starting at 6:01 PM.
- \$50.00 up to 6 hours of care on days school is closed.
- \$80.00 up to 11.5 hours of care on days school is closed.
- \$30.00 reduction for the 2nd lowest tuition in a multiple child family.
- NO MORE combining hours for AM & PM, they are separate sessions.

If your child will be returning to Stay and Play in the fall, please <u>return this form by Thursday February 29, 2024 along with your \$60.00 registration fee per child.</u> After this date, we will open registration to those on our waiting list and I cannot guarantee your child's spot.
